## **Application Form**

Units that will struggle to pay their subscription bill in 2025, can apply for a grant of up to £500 provided:

- Their accounts aren't overdue
- They haven't received funding in R3 of GGF (Sept Dec 2024)
- They've not received CashBack funding for subscriptions since April 2024 (if eligible)

We must receive one application per unit. Applications covering multiple units will be rejected.

The grant can be used to cover girl subscription and volunteer subscriptions only.

You will need the following information to make an application:

- The name of the unit as it appears on GO
- The unit level number (this can be found on GO)
- · How many girls will benefit from the funding
- How many volunteer will benefit from the funding
- How much the annual subscription is for the unit
- A recent bank statement (dated from within the last 3 months) and the current balance on the account as well as the reason for any money you are holding onto.
- If you do not have a bank account, you will need to tell us why not and how much money the unit has access to.
- Any specific reasons as to why the funding is needed/ the unit will struggle to pay the subscription this year.

The fund will be open from 22 January to 9 February 2025.
