The fund will open to new applications at 9am 24 February 2025 and close at 11:59pm 4 April 2025. This funding round is for activities happening and/or costs that will be incurred between July 2025 and January 2026. Applications will not be accepted for costs incurred in or projects or activities taking place outwith this time.

No decisions will be made until after the deadline has passed. We'll let everyone know the outcome of their application by 16 May.

The panel will base their decision on the information you provide in this form so please complete it as fully as possible.

The person completing the application form should be the person best placed to answer questions about the application. You should not enter someone else's contact details without their permission and without them seeing the application in full. The person named here will also be responsible for completing the evaluation form if the application is successful.
